The Need for Choosing LIMS over Manual Data Maintenance

Novast could handle the first audit of USFDA well even though their lab data was manually kept. But the need for shifting to digital systems became more prominent. By the next audit, they wanted to have a better compliant system in place that could help them:

With a target to drive efficiency, quality, and compliance, Novast was looking for a robust LIMS application that would accommodate smooth transition from manual to digital system.

Novast implemented CaliberLIMS Version 3.3.0 in the year 2017. The following 17 standard modules of the system were adapted in place of manual procedures.

The Digital Journey


Novast faced a few initial hiccups during the implementation process. With determination and an able digital partner like CaliberLIMS, it could easily overcome the issues.

1. Overcame language barrier

Being a company with majority of Chinese speaking employees, Novast faced language barrier issues up to a certain extent during implementation process. However, they didn't find any issue in adapting to the system as CaliberLIMS is user-friendly. Novast's existing procedures were followed with no customizations. There were hardly a few configurations in the application.

2. Complex network system

Another challenge Novast faced was that of complex network used for their security systems. They had multiple networks in one lab with different instruments connecting to different networks. But by using the robust instrument interfacing platform of Caliber, they managed to connect to different complex networks at a time. The system could connect to 17 instruments and 1 CDS (Chromatography Data System) system during implementation.



Phase-wise Implementation for Smooth Manual to Digital Transition

The whole implementation process was completed in merely 5 months. Novast made a 5-member team – three from QC and two from QA. Three members created Masters and two members reviewed them. It took one and half month to finish the task.

In-process and finished products were implemented first followed by APIs as suggested by the Caliber team. Finished products were specifically picked for implementation process as Novast had to share COAs with customers.



CaliberLIMS Extensive Support



Thorough training

Novast staff underwent thorough training for 22 days including theory sessions and hands-on activities. With the use of scenario-based approach and real-time use cases, the Novast users could get acquainted with the system and use it to perfection very quickly.



Novast chose to get the implementation done in a faster way through offsite validation. It is one of the multiple implementation methodologies followed at Caliber. Instead of having one or two on-site validation resources, Novast was provided with 3 to 4 offsite. validation resources under offsite validation process. The resources were connected through secure VPN. The process of implementation was very elaborative and stringent as per the regulatory standards of GAMP5.



Novast received remote support from Caliber. Major part was cleared and validated. They had a separate support portal through which they could track the time taken to resolve issues. A dedicated support team from Caliber provided them assistance.

The Result

1. Ease in Audits

Novast faced many FDA, NMPA (CFDA) audits so far. They are the only company in China that successfully completed 4 consecutive FDA audits with zero observations. The complete implementation process from the time of implementation to PQ document was explained to FDA and other auditors using CaliberLIMS system.

2. Increased efficiency of QA

There was a considerable reduction in the review time with review alerts, reduction in redundant and repeated data entry work, thus resulting in increased efficiency of QA. The review time for finished products could be completed in shorter durations. QA could see whether the chemist has used correct quantity of sample, working standard, chemical standard, etc.



Digitalization of lab with CaliberLIMS helped in reviewing a greater number of batches in less time resulting in increased production.

3. Reduction in time and effort of users and operators

The users and operators saved a lot of time and effort by using LIMS. To get the details of the chemical usage, they had to manually note down the details in a paper worksheet visiting respective chemical area earlier. But after CaliberLIMS implementation, the data was automatically fetched. Similarly, to perform analysis and transcript of a finished product sample, with an average of 12 to 13 tests, the turnover time for complete manual work from operator was 5 days which now reduced to 3 days.

4. Readily available trend analysis

Extracting data for APQR generation became quick and easy with CaliberLIMS. Earlier, manual entries were required to generate a trend. But now data could be easily pulled with product name and product code within half an hour.

5. No delay in work in the absence of chemist

Earlier, work would get affected in the absence of chemist and group leader due to lack of proper communication. But after digitalization, the system assists in transferring work to others in case someone is on leave. So, all the evidence details of who initially performed the tests, who transferred the tests, and who did it later are available. It helps in tracking the person who committed mistakes during an investigation process.

Further, in case a chemist leaves the company, the QC tests are transferred to others on the relieving date without any hassles.

6. Collation of important data

Novast could also benefit from the system in collecting data on number of samples received, number of COAs generated, deviations, OOS, CAPAs raised, etc. which were presented once every year to the management.

By improving the efficiency and helping to meet regulatory requirements stringently every time, Caliber has become a true robust digital partner of Novast over the years. This association instilled more confidence in Caliber and its products. Their journey together will help Novast foray into new markets and expand tremendously.
